Call for applications Academic Year 2026/27

The University of Pisa announces for the Academic Year 2026/27 a public competition, open to non-EU citizens not resident in Italy, for admission to the Master's Degree in Cybersecurity (Laurea Magistrale, class LM-66).

The competition aims to admit (an average of 40) non-EU applicants, who must apply and undergo an evaluation procedure. The submitted documentation will be assessed by the Master's Degree Evaluation Committee (EC). Shortlisted applicants will be eligible for admission and ranked.

The outcome of the evaluation will be made available to applicants in the site for application only at the very end of the evaluation procedure.

Admission requirements

Applicants must either hold:

- a Bachelor of Science, or equivalent first-cycle degree, obtained abroad after the completion of a three-year (minimum) course of study, in Computer Science or in Computer Engineering or any other degree providing a suitable background in both mathematics and computer science or computer engineering. The admission of candidates holding a qualification issued in a non-EU country will be subject to verification and recognition of legitimacy by the Italian deputy diplomatic authorities.
- It is strictly required for applicants to hold a CGPA (Cumulative Grade Point Average) equal to or above 75% of the maximum grades (e.g., 3 in a scale of 4, or 15 in a scale of 20; please note that no institution-specific grade-to-percentage conversion rule is considered for this purpose). The CGPA must be computed on all the exams (including elective ones) over all the years of the first-cycle degree and must be substantiated by the submitted official documentation. Any application with a CGPA below the 75% threshold will be automatically excluded from the competition.
- any bachelor equivalent to an Italian Laurea degree of classes L-8 or L- 31, or, otherwise, a bachelor with:
 - at least 18 CFUs taken from learning activities in the sectors of mathematics of physics (that is, in the Italian sectors MAT/*, FIS/*)
 - at least 36 CFUs taken from learning activities in the sector of Information technology (that is, in the Italian sectors ING-INF/01, ING-INF/03, ING-INF/05, INF/01).

Knowledge of the English language, comparable to the **level B2** of the Common European Framework of Reference for Languages, is also required.

Application procedure and due documentation

Before applying please note that the result of the selection of the candidates will be available only at the very end of the procedure, as indicated below.

Applicants shall apply online at https://applymscenglish.unipi.it.

In the application form, applicants must include:

- a declaration of knowledge of the English language, specifying the duration of studies and the type of certification held;
- certification of the academic degree they possess, with an indication of the legal duration of the course (at least three years), together with a copy of the degree certificate and transcripts (translated to English or Italian);
- a copy of a valid passport;
- a copy of their complete Curriculum Vitae et Studiorum covering their education program.

Applicants may also include other documents (e.g., letters of reference and other certificates including any other relevant cultural and professional experience that might help the EC to evaluate the applicant). All documents must be in Adobe pdf format.

Applications missing any of the required documents are not considered valid and will not be processed further. Applications cannot be integrated after the call deadline.

Application fees

Applicants intending to submit their admission application for the Master's degree program in Cybersecurity at the University of Pisa, available through the application portal at the link https://applymscenglish.unipi.it, are informed that payment of an application fee of 30€ will be required.

The application fee is mandatory for submitting an admission application for the 2026/2027 academic year. Each applicant may submit up to two applications for programs available on the application portal. Please note that the application fee must be paid for each application submitted; therefore, in the case of two applications, two separate fees will be required.

Eligible Applicants: The application fee applies exclusively to applicants holding a foreign qualification. **Payment Method**: Payment must be made directly on the application portal https://applymscenglish.unipi.it. The payment will be requested immediately after completing the application, prior to its submission to the evaluation committee.

Important Note: Submission of the admission application for the 2026/2027 academic year will only be possible upon payment of the required application fee. Candidates who do not complete the payment will not be able to submit their application.

Application deadlines and selection schedule

- applications are open from January 12th, 2026 to February 5th, 2026, 12:00 pm (GMT) [strict]
- interviews of selected candidates are scheduled from February 10th, 2025 to February 28th, 2026 [tentative]
- notifications of admission will be published by March 7th, 2026

- notifications of rejection will not be sent by e-mail, but they will be published in the portal by March 7th, 2026.
- Note that no communication will be sent before the end of the selection process.

Prospective applicants are therefore encouraged to apply at their earliest convenience. In case of problems with the online application, please get in touch with our international office (https://www.ing.unipi.it/it/internazionale, international@ing.unipi.it).

Please note that the result of the selection of the candidates will be available only at the very end of the procedure, namely after February 5th. The results will be available directly on the portal for applications and no email will be sent for notification. Note that "not admitted" or "non ammesso" in the portal means that the application of the candidate did not pass the evaluation and then the candidate is not admitted to the M.Sc. In Cybersecurity. Evaluation procedure

The documentation submitted by applicants will be evaluated by the Evaluation Committee (EC), consisting of Information Engineering and Computer Science professors. The committee will assess the applicants' background and education, their potential skills and attitude to attend an interdisciplinary and innovative educational programme, and grade them on a scale of 60 points. Applicants scoring less than 42 points will be rejected. Applicants scoring 42 or more will be shortlisted for an interview.

Applicants shortlisted for the interview will be informed via e-mail (sent to the account indicated in the application form) about the time and date of the interview. Interviews will be held through videoconference. The applicant shall provide the proper settings to carry out the video interview and exhibit the ID submitted in the online application. Applicants not attending the interview in their scheduled slot will be excluded. Applicants will be interviewed by the EC, who will evaluate their motivation, expectations, and technical skills, as well as their mastering of the English language. Interviews will be graded on a scale of 40 points. Shortlisted applicants scoring less than 28 points will be rejected. Instead, applications scoring at least 28 points at the interview will be eligible for admission.

What to do upon admission

Admitted applicants will first need to confirm by email their intent to pre-enrol, by replying to the email notifying their admission. Upon confirmation of their intent to pre-enrol, the admitted applicants will receive a formal admission letter by email. The letter must be included in the pre-enrolment documentation to be unloaded on the UNIVERSITALY website so as to be submitted to the Italian Embassy/Consulate - by a deadline which is to be verified by the students - and to apply for a Student Visa. Please note that completing the pre-enrolment and Student Visa procedures might take several weeks, depending on the Italian Embassy/Consulates, and that the University of Pisa cannot liaise with the Embassy/Consulate on your behalf under any circumstance. Students that have successfully pre-enrolled on Universitaly and have obtained their Student Visa will be able to come to Italy, where they will follow the procedure to enroll at the University of Pisa. Admitted students must also inform the EC of their final Student Visa status by sending an email to our international office (international@ing.unipi.it).

Fees and Financial Support

University fees are determined annually by the Board of Directors and must be paid each academic year. Fees are usually announced in June for the following academic year. For 2025/26, fees range from €446 to €2,900 per year, depending on the student's country of origin.
